Insurance Services Office (ISO) has submitted a recommendation concerning your community's Public Protection Classification (PPC). Currently, the Community's Public Protection Classification rating is a Class 4/8B.

Insurance Services Office is recommending the classification be changed to a Class 3, with an effective date of 01/01/2014. The recommendation is based on a review of your community performed on 04/17/2013 and does include application of the Texas Addendum.

With a single class rating of 3 all class-rated properties will use **Class 3**.

Public Protection Classifications range from 1 (best) to 10 (worst).

We have reviewed the information provided and believe it is sufficient to grant approval. Enclosed is a PPC Submittal sheet indicating the point totals for the major areas associated with the review. The Insurance Services Office will be notified of our approval of their recommendation and the 01/01/2014 effective date.

Please make sure all community officials and residents within your district are notified of the new Public Protection Classification rating for your community, and the effective date.

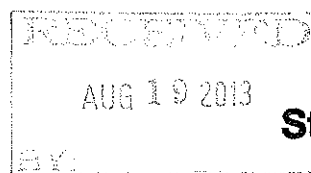
