- 5. Report from the Firefighters' Union Firefighter Scott Elkins reported that the new squad is really helping the department as a whole. With much faster response times as well as relieving calls for Station's 901 and 902. They have also noticed that with the new squad they are able to release additional units while they continue to stay on scene. Scott still hasn't received the final approval yet on the benevolent fund. As budget season is approaching the union has made a couple of requests for the board to consider. Scott presented some concerns with our current Time and Grade Schedule, and made a suggestion on how to fix the issues. The union also asked that the Board to consider an increase to the amount that the department pays for the family insurance premiums.
