- 3. Review and Approve Minutes for the May 3, 2022, Public Hearing and Regular Meeting. A motion was made to approve the minutes from the May 3, 2022 meeting. (M SH, 2<sup>nd</sup> DK, V Unanimous)
- 4. Citizens' Communication The Board of Commissioners welcomes public comments at this point on any issue, whether or not included as an item on the agenda. Scott shared some information from our neighboring departments and what they are paying their Fire Fighters after this past year's increase. He also discussed rent and mortgages going up as well as fuel and food.
