IT IS THEREFORE RESOLVED BY THE COMMISSIONERS OF TRAVIS COUNTY EMERGENCY SERVICES DISTRICT NO. 9 THAT:

Section 1. The Elections were duly called and notice thereof given in accordance with law; the Elections were held in the manner required by law; only resident, qualified electors of the District and of the Proposed Annexed Territory, respectively, voted at the Elections; a written return of the elections results was made to the District in accordance with the Election Code; a majority of the resident, qualified electors of the District voting in the Elections, including absentee voting, voted "FOR" Proposition A, and "FOR" Proposition B; and a majority of the resident, qualified electors of the Proposed Annexed Territory voting in the Elections, including absentee voting, voted "FOR" Proposition A, and "FOR" Proposition B

Section 2. The official returns shall be delivered to the District's custodian of local election register, who is hereby directed to enter in the election register the tabulation of the votes cast for and against the Propositions in the District and in the Proposed Annexed Territory and to preserve such tabulations as required by law.

Section 3. The District Board of Commissioners finds, determines, recites and declares that written notice of the date, hour, place and subject of the meeting at which this Resolution is adopted was posted on a bulletin board located at a place convenient to the public for at least 72 hours preceding the scheduled time of the meeting; that a telephonic or telegraphic notice of such meeting was given to all news media who have consented to pay any and all expenses incurred by the District in connection with providing such notice, both as required by Chapter 551, Texas Government Code; and that such meeting was open to the public as required by law at all times during which this Resolution and the subject matter thereof was discussed, considered and formally acted upon.

Section 4. The presiding officer of the meeting at which this Resolution is adopted is authorized to execute and the District Secretary is authorized to attest this Resolution on behalf of the District.

Section 5. This Resolution is effective immediately upon its passage and approval.
